Helping you build new networks

Members of PraxisUnico can attend our training courses, events and annual conference at discounted rates.

The conferences, briefings and debates that we organise throughout the year are a great way for our members to network with colleagues from organisations from across the sector. Regular attendees and speakers include representatives from higher education, government, industry, professional firms, Public Sector Research Establishments and the NHS. Membership provides regular opportunities to share ideas and best practice.

We also facilitate events with collaborators that allow our membership to network with high-level representatives and important stakeholders from funding sources in government and elsewhere, and from other sectors and industries that influence and affect our profession - outside the core technology/knowledge transfer community.

Our member-only Directors' Fora, for Directors and Heads of Office from PraxisUnico member organisations are designed to debate key questions, share best practice and advance knowledge across a broad range of topics. Speakers include some of the leading practitioners, policy-makers and influencers from industry, government and academia.

Our training courses are also a great place for those new to the profession to begin to build their own personal networks, or to build on existing networks. Our members are the first to hear of new courses opening for registration.

Our network reaches around the world through our international collaborations with similar associations.

Professional development and recognition

We are committed to supporting the profession and achieving professional recognition for its practitioners. We will continue to work with other professional organisations to enhance careers, professional growth and opportunities.

As part of an ongoing aim to enhance value for PraxisUnico Members, the PraxisUnico website acts to signpost information relating to UK KT activity, expertise, success and impact.
